Most important substantial contributions

I have made substantial contributions in several fields, perhaps most notably in: (i) theory and methodology of social sciences, especially through applying and developing critical realism, involving an open-systemic account of causation and critical reflexivity about the future; (ii) political economy, both via constructing political economy explanations of various processes and outcomes and in terms of developing and proposing alternative policies and institutional arrangements; and (iii) global political theory, focussing on global governance in terms of sustainable well-being, social justice, democracy as well as peace and security. The logic of critical social-scientific explanation, and a related theory of human emancipation, is the main thread connecting these areas.

In the IS Web of Knowledge social sciences citation index, my works have been cited 1,000 times; in Research Gate, 2,000 times (h-index 22); and 5,600 times in Google Scholar (h-index 33). My name gets more than 55,000 hits in Google Web/URL. All this indicates a large and perhaps growing international recognition. I have given dozens of guest lectures around the world and presented papers at least two hundred international conferences and seminars, in several of them as a keynote speaker. I am particularly delighted that this recognition crosses disciplinary boundaries and is in no way confined to International Relations or Global Political Economy. In 2018, I became a member of The Finnish Academy of Science and Letter; and since late 2019, I have been a lifelong member of Clare Hall, the University of Cambridge (visiting fellow in 2018-19).

There are many nice reviews and praises of my academic work. A favourite quotation comes from a review of *After International Relations. Critical Realism and the (Re)Construction of World Politics* by Howard Richards: [This book is] "a rescue operation designed to rescue words like 'truth,' 'reality,' and 'cause and effect'".

Academic reviews characterize the 2001 book *Democratizing Globalization* as a "superb theoretical analysis of the current financial system" and "an excellent, if ambitious, practical proposal for the reform of the global financial system" (*Millennium: Journal of International Studies*, 2001); and as an "impressive accomplishment" that, "by presenting solidly-grounded arguments, makes a constructive move forward in the debate about democratizing (financial) globalization" (*International Affairs*, 2002).

My 2004 global democracy book *A Possible World*, with Teivo Teivainen, was equally well received in academia. The fact that it has been published in five languages – Arabic, English, Finnish, Spanish and Swedish – indicates popularity beyond the English-speaking academia. *The Political Economy of Global Security* came out in late 2007. In his foreword, Richard Falk writes: "It is a book that needs to be read, studied, and reflected upon by all those who care about a better future for humanity, that is, hopefully, and realistically, almost all of us!" In a book review in *International Affairs*, Mathias Albert notes: "This is without doubt one of the most intellectually rewarding IR books published in recent years".

Neoliberalism in Finland, published in late 2007, was written for the Finnish popular audience, although its perspective is global and future-oriented. With widely publicized reviews and commentaries – including some controversial ones – across the national media, it reached #3 in the list of best-selling non-fiction in the main bookshops. It was out of print in a few weeks. Following the equally successful second edition, a new third edition was published online in 2015. A more recent book on the Euro crisis, *The Great Eurozone Disaster*, which is both explanatory and future-oriented in proposing alternative policies and institutional arrangements, fared even better. The first Finnish edition reached instantly #2 in non-fiction. The subsequent 2013 Zed Books version in English stayed for months on the publisher’s list of top five best-selling books. It has also been translated into Greek and published by one of the main commercial publishers in Greece, Metaixmio.

Two recent political economy books are: *Disintegrative Tendencies in Global Political Economy* published in 2018 (paperback in August 2019; open access since June 2020) and *The Three Fields of Global Political Economy* in March 2022, both by Routledge. The former is a follow-up work to the *Political Economy of Global Security* and a warning that the possibility of global military catastrophe is increasingly likely, and includes a chapter on the conflict in Ukraine. The latter is a theoretical opening and an attempt to explain world history from a novel field-theoretical perspective and in terms of collective learning. This perspective shapes and constitutes my arguments also in *Debating the War in Ukraine: Counterfactual Histories and Future Possibilities*, with T.Forsberg (Routledge, hardback and e-book December 2022, paperback later). The most recent book and perhaps my *magnum opus*, *World Statehood. The Future of World Politics*, was published in July 2023 (Springer), with a major review in *Journal of Critical Realism* and a full forum in *Cooperation and Conflict* in summer 2024 (including statements such as “the arguably most sophisticated defence of world statehood to date”).

My popular and political writings have drawn attention both in the media and in the circles of public policy making, also beyond the countries where I have lived. For instance, I was invited to the Scientific Board of the Progressive Economy (PE) in 2015. While the PE initiative came to an end in March 2018, I continue to be involved in the S&D group’s network of experts. In spring 2017, I was invited to take part in a new pan-European blog, BRAVE NEW EUROPE, created by international journalists; my texts have appeared there since late 2017. The Great Transition Initiative invited me to write a new essay on the idea of a world political party in 2018 and since then I have contributed to many related forums, becoming an Associate Fellow of the Tellus Institute in 2022.
